Management's Note

The total value of XYZ Investments is now C\$147,852,831 million representing a (1.25%) decrease from last quarter. The change in value was impacted by taxes paid.

The portfolio has generated a return of 0.10% compared to the benchmark return of (1.45%) for the past quarter.

Markets are dominated by headlines related to politics and international trade, dragging down global stock prices. Here is a summary of key developments for XYZ:

- Shareholder Engagement: We galvanized other investors totaling \$35 billion of assets to sign a letter urging Canadian banks to re-commit to net-zero banking after they withdrew from the Net-Zero Banking Alliance. It received media attention and a de-brief with investors to share their input is planned for next quarter. We also presented at the TD annual meeting about the bank's renewable energy funding ratio.
- **Asset Allocation:** US equities remain the largest allocation at 50%, followed by cash & cash equivalents at 14.71%. This conservative allocation has enabled XYZ to outperform its portfolio benchmark during the past quarter as stock markets have fallen.
- **Economic Environment:** Since the end of the quarter, stock markets have fallen sharply. Investor sentiment has turned bearish based on trade and political disputes.
- Strategic Adjustments: Real estate remains an asset class we do not have an allocation to. Management is evaluating real estate investments that can meet the objectives of supporting affordable housing and climate positive.
- **Unfunded Commitments:** XYZ has \$7.84 million of unfunded commitments to investment funds. Considering cash after adjusting for these commitments, the allocation to cash would be 9.4%.

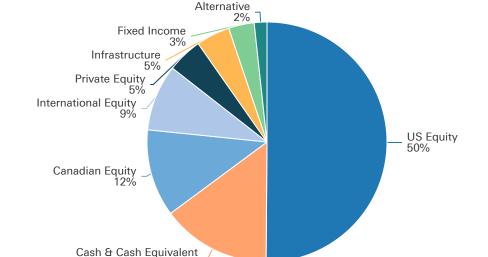

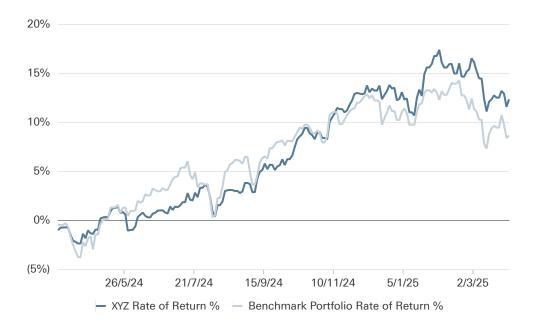

XYZ Performance vs Portfolio Benchmark - 1 Year

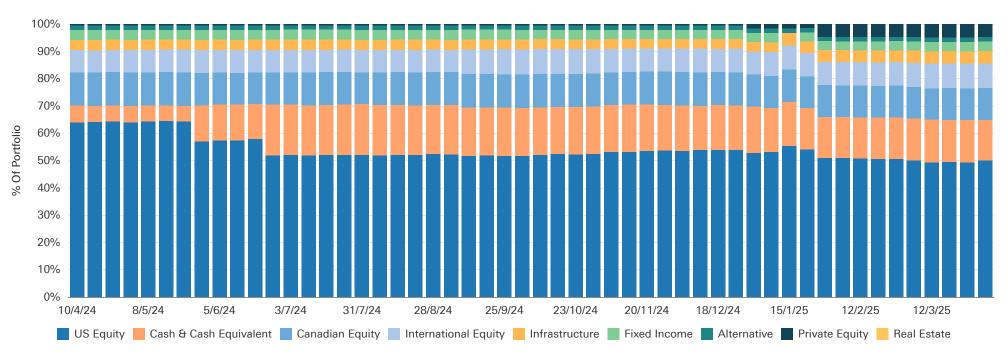

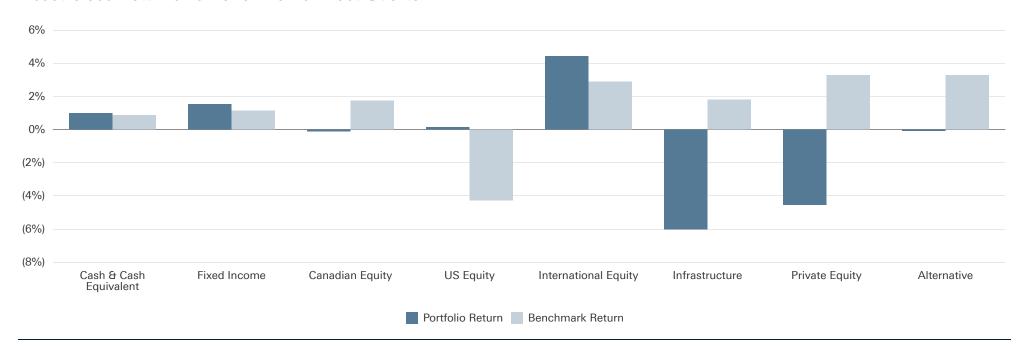

Asset Class Returns vs Benchmarks - Past Quarter

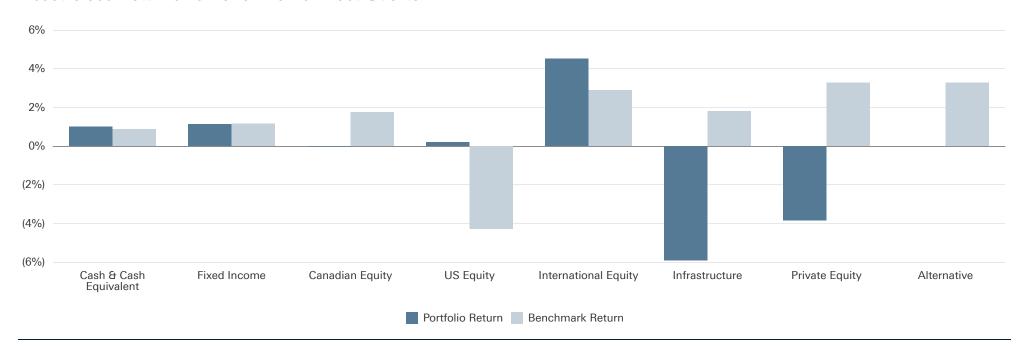

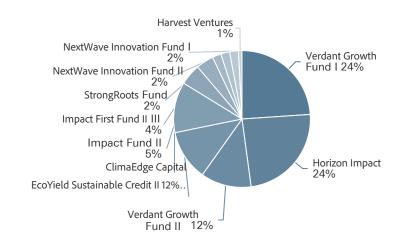

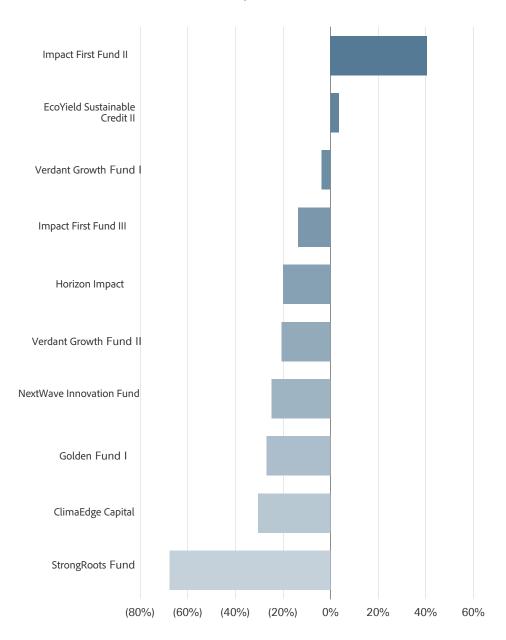

Canadian Equites vs Benchmark - 1 Year

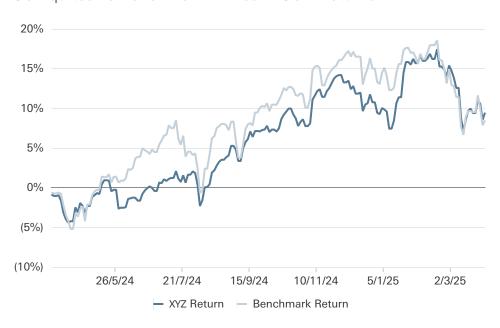

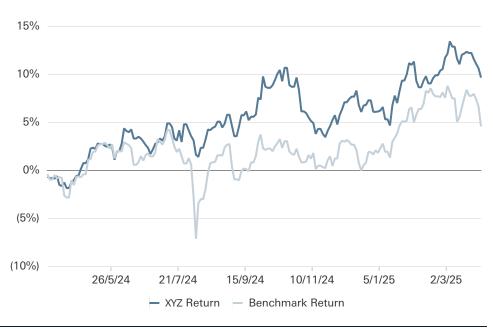
XYZ's equity market investments performed roughly in line with benchmarks over the past quarter.

International Equites vs Benchmark - 1 Year



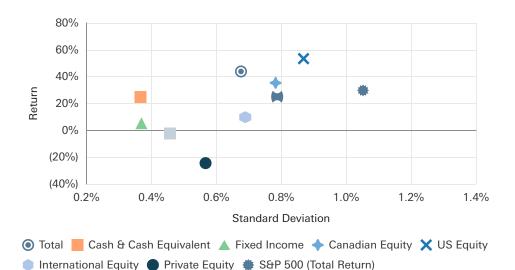

XYZ Performance vs Portfolio Benchmark - 3 Year

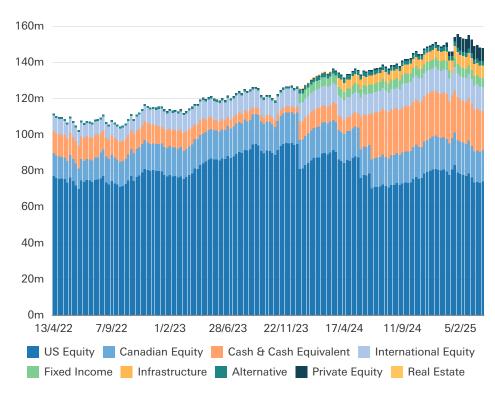


Risk vs Returns - 2 Year

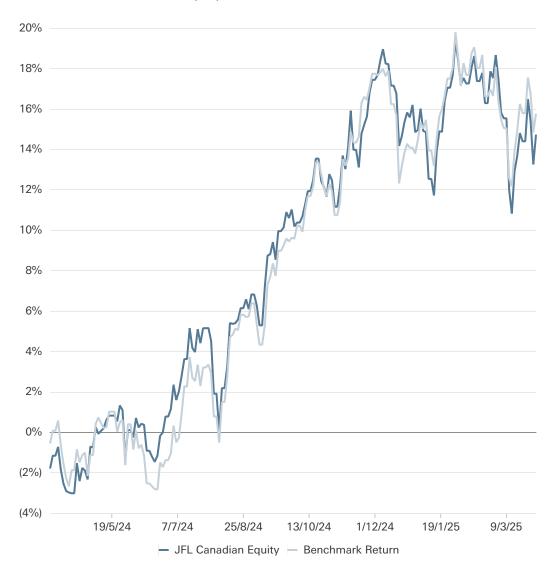

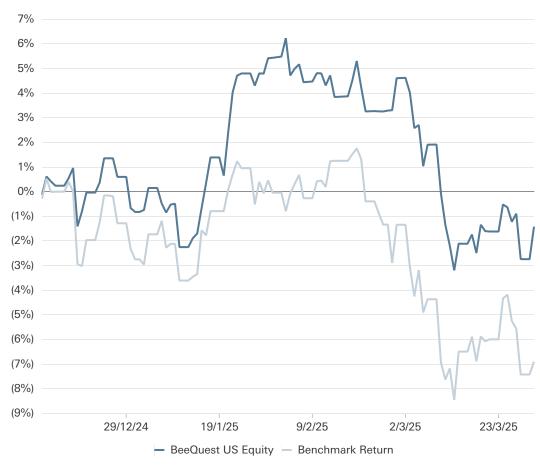
